About the Canadian Taxpayers Federation

Regional offices conduct research and advocacy activities specific to their provinces in addition to acting as regional organizers of Canada-wide initiatives.

CTF offices field hundreds of media interviews each month, hold press conferences and issue regular news releases, commentaries, online postings and publications to advocate on behalf of CTF supporters. CTF representatives speak at functions, make presentations to government, meet with politicians and organize petition drives, events and campaigns to mobilize citizens to effect public policy change. Each week CTF offices send out Let's Talk Taxes commentaries to more than 800 media outlets and personalities across Canada.

Any Canadian taxpayer committed to the CTF's mission is welcome to join at no cost and receive emailed Action Updates. Financial supporters can additionally receive the CTF's flagship publication *The Taxpayer* magazine, published three times a year.

The CTF is independent of any institutional or partisan affiliations. All CTF staff, board members and representatives are prohibited from donating to or holding a membership in any political party. In 2018-19 the CTF raised \$5.1 million on the strength of 30,517 donations. Donations to the CTF are not tax deductible as a charitable contribution.

Alberta's ballooning municipal labour costs

Labour costs make up a significant portion of municipal government budgets. If municipal governments are going to significantly reduce costs to provide necessary tax relief, many will need to address their growing labour costs.


Based on data published by the Alberta government, the Canadian Taxpayers Federation analyzed how municipal government labour costs have increased between 2014 (the beginning of the oil price collapse) and 2018 (most recent data for all municipal governments). As illustrated in the table below, Alberta's municipal government labour costs have increased by about \$873 million, or 16.9 per cent, between 2014 and 2018.

This is in stark contrast to the realities facing Alberta workers outside of government. According to <u>Statistics Canada data</u>, total compensation for Alberta employees has declined by six per cent between 2014 and 2018. The difference between municipal government labour costs and the province-wide change in compensation is illustrated in the figure to the right.

The rest of the report will highlight how government labour costs have increased in large, medium and small Alberta municipalities.

Note: The provincial government's labour costs have increased by 12.7 per cent or \$3 billion between 2014 and 2018, according to budget documents.





Big cities (population: 30,000+)

Labour costs for the big Alberta cities increased by 15.8 per cent between 2014 and 2018.

The three cities with the fastest growing labour costs between 2014 and 2018 are:

- 1. Leduc = 33.3 per cent increase
- 2. Spruce Grove = 31.9 per cent increase
- 3. Airdrie = 30.9 per cent increase

Medium-sized municipalities (population: 5,000-30,000)

Labour costs for the mid-sized Alberta municipalities increased by 23.4 per cent between 2014 and 2018.

The three mid-sized municipalities with the fastest growing labour costs between 2014 and 2018 are:

- 1. Municipal District of Taber = 56.1 per cent
- 2. Municipal District of Greenview = 54.8 per cent
- 3. Blackfalds = 52.8 per cent
