### Mr PRESIDENT:

I give notice that on the next sitting day I will move:

- (1) That this House notes that:
  - (a) on 12 October 2020, NSW Parks and Wildlife commenced an aerial 1080 baiting program in the Tallaganda area,
  - (b) the 1080 poison baits being dropped in the Tallaganda area by NSW Parks and Wildlife are being done so in close proximity to local residences and A Place of Peace, the largest farmed animal sanctuary in New South Wales,
  - (c) 1080 is an indiscriminate poison that is lethal to many animals,
  - (d) an animal that ingests 1080 poison will suffer a slow, agonising death, that starts with vomiting, anxiety, disorientation and shaking, followed by frenzied running, screaming fits, and seizures which can last up to 48 hours before their eventual death,
  - (e) on 12 October 2020, the same day aerial baiting commenced in the Tallaganda area, Ruby, the dog of a local family, died a horrific and prolonged death due to suspected 1080 poisoning, and
  - (f) Ruby's death follows reports of nine other dogs being killed from confirmed or suspected 1080 baiting in parts of Queensland in recent weeks.
- (2) That this House calls for an immediate ban of 1080 baiting in New South Wales
