□ **Poll Observer at Traditional Polling Locations** – Observe electoral process at polling locations, ballot drop-off centers, and the county Clerk or County Registrar's office.

- □ **Poll Observer at Vote Center or Consolidated Polling Locations** Observe electoral process at Vote Center locations, ballot drop-off centers and the county Clerk or County Registrar's office.
- □ Ballot Processing at Registrar's Office or Ballot Processing Centers (Dates may vary depending upon the county) Observe ballot processing including signature verification, remaking of problematic ballots, secure transportation of ballots and other such procedures that take place before and after Election Day.
