<u>Likely deceased mailed ballots</u>= Active status registrants who match a California Death Index record on first-mid-last name, date of birth, place of birth. Includes those who died at their voter registration addresses. Excludes common names which could be coincidences. Were mailed ballots.

<u>Mailed 2+ ballots</u>= registrants who appear to have two or more Active status registrations (same first-mid-last name, date of birth, address.) At differing addresses, have matching phone number and/or email. Includes married/maiden name changes. Excludes possible twins and common names which could be coincidences. Were mailed 2+ ballots each due to 2+ Active registrations.
