

The survey has a margin of error of +/- 3.7 percentage points. Results are weighted. Some percentages in crosstab reports for this poll may not add to 100% due to rounding.

Are you 18 years of age and registered to vote in the state of North Carolina?



How likely are you to vote in the November 3rd General Election in North Carolina? Would you say you are extremely likely, somewhat likely, or not very likely?





































What is your total household income?






