IMPLEMENTATION OF IMPORT OF NON HAZARDOUS AND TOXIC MATERIAL WASTE AS RAW MATERIAL INDUSTRY

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF TRADE, THE MINISTER OF ENVIRONMENT AND FORESTRY, THE MINISTER OF TRADE INDUSTRY, AND HEAD OF STATE POLICY OF THE REPUBLIC OF INDONESIA,

Weigh:

1-7 [existing laws]

Set:

Decree of the Minister of Trade, the Minister of Environment and Forestry, Minister of Industry, and Head of State Policy of the Republic of Indonesia Concerning Implementation of Non Hazardous and Toxic Waste Import as Industrial Raw Materials.

First:

This Joint Decree is used as a guideline for the import of hazardous and non-hazardous and toxic waste as an industrial raw material.

SECOND:

Tolerance of material content follows as well as imports of non-hazardous and toxic waste as referred to in the FIRST Dictum for paper and plastic groups is set at 2 (two) percent.

THIRD:

Tolerance of oil content, oil emulsion, lubricating oil and grease to imports of non-hazardous and toxic waste as referred to in the FIRST Dictum, for groups of metal in the form of iron or steel scrap is visible in small amounts and not dripping.

FOURTH:

- a. In the context of accelerating the availability of domestic industrial raw materials for the paper and plastic group as a substitute for imported raw materials of non-hazardous and toxic waste, Ministry of Industry, Ministry of Environment and Forestry, and Ministry Trade compiles a road map for the management of non-hazardous and toxic waste materials as an industrial raw material.
- b. The road map as referred to in letter a, also includes reduction of boundaries tolerance of the accompanying material content as referred to in the SECOND Dictum and reduction import quotas in stages, adjusted for the availability of raw materials for group industries domestic paper and plastic groups.

FIFTH

The road map as referred to in the FOURTH Dictum is compiled for a maximum of 6 (six) months since this Joint Decree was adopted.

SIXTH

- a. In the context of monitoring the import of non-hazardous and toxic waste, the Minister of Trade is to form a Task Force on the Import of Non-Hazardous and Toxic Waste with members at least officials / representatives from the Ministry of Trade, the Ministry of Environment and Forestry, Ministry of Industry, Ministry of Finance, Ministry of Foreign Affairs, and Republic of Indonesia National Police, the formation of which is carried out in accordance with the provisions laws and regulations.
- b. The Task Force as referred to in letter a, draws up Standard Operating Procedures (Standard Operating Procedure) for the implementation of this Joint Decree.

SEVENTH

This Joint Decree shall come into force as from the date of stipulation.
