International Travel Final Report

Premier Jason Kenney Mission to Texas, United States November 19–21, 2019



Overview:

From November 19-21, 2019, Premier Kenney conducted a mission to Houston and Dallas, Texas. He met with investors and business leaders and spoke about the government's commitment to making Alberta an attractive and competitive destination for investment.

The mission was successful in meeting its objectives as outlined below.

Mission Objectives:

- Restore investor confidence by raising awareness of Alberta's growth strategy, including the Job Creation Tax Cut, Red Tape Reduction, and recent decisions like special production allowances.
- Reaffirm Alberta's position as a critical supplier of energy resources to Texas and North America.
- Underscore how Alberta continues to be the most stable, secure and environmentally responsible energy supplier to the U.S.

Results:

Houston

The Premier met with a major company to hold a detailed discussion regarding their plans for future investment. The Premier discussed Alberta's new competitiveness initiatives and how the Government of Alberta can work with investors to address project-related needs. He committed to working closely with the company as they considered their investment plans.

Premier Kenney had eight meetings with energy companies operating throughout the oil and gas value chain and promoted Alberta as a strong candidate for future oil and gas development due to the province's positive business climate, geology, and long-term demand for light hydrocarbons.

The Premier also spoke to refiners regarding Alberta's commitment to ending curtailment in a systematic way that avoids the need for future intervention in the energy market. The Premier confirmed Alberta's commitment to remaining an energy supplier of choice to the U.S.

In his meetings with investors, the Premier outlined Alberta's competitiveness policies and discussed opportunities in the Alberta economy.

Dallas

Premier Kenney met with Exxon and discussed Alberta's approach to curtailment. He committed to continued dialogue with Exxon and reaffirmed Alberta's commitment to building a competitive and predictable investment climate.

The Premier also met with the Consul General of Canada to Dallas and discussed Alberta's plans for representation in Houston and potential collaboration with the federal government.
