Dear Commissioner Stephanie Garcia Richard,

The Customs and Border Patrol ("CBP") has a history of discriminating heavily against people of color at our nation's southern border in the name of national security. What is more, the land they are currently surveilling is stolen Indigenous land where sacred sites are being destroyed with no regard for the significance of the site or the heritages to which the sites belong. They have routinely violated the human rights of people of color by separating children from their loving parents or caregivers; denying the ability of migrating people to seek asylum in the United States in accordance with United States and international law; detaining people in their custody indefinitely; and destroying cultural properties and landscapes that also disrupt wildlife and plant species. These kinds of human rights abuses are not aligned with the communities who call New Mexico home or the people coming to this country for a better life. We, the undersigned, cannot tolerate a state agency collaborating with any agency committing these human rights abuses, especially in the current climate.

Indigenous Women Rising submits this letter to you on behalf of the signers below and we ask that you *do not* sign this Programmatic Agreement with CBP and that you continue to work to protect cultural properties on state trust land. The State Land Office is capable of doing this without such an agreement, as the CBP is a federal agency, and already has authority to be on state lands with little notice.
