Dear Members of the General Assembly:

As Secretary of the Commonwealth, I am pleased to report on the administration of voter registration in Pennsylvania for calendar year 2022. I trust you will find this information useful.

The administration of voter registration in Pennsylvania is a joint effort between county and state officials. In 2022, the Department of State worked with the state's 67 county election boards and voter registration commissions to provide voter registration opportunities to eligible residents of Pennsylvania and to enhance our efforts to maintain the accuracy of voter rolls. This partnership between state and county officials promotes civic participation while improving the integrity of our elections.

To achieve these dual purposes, the Department supports counties in a variety of ways, including providing voter education materials, making available official voter registration and mail ballot application forms both in print and online in multiple languages, and distributing data to counties identifying voters who may have moved and voters who are deceased. The Department also continues its collaboration with various state agencies designated under the National Voter Registration Act of 1993 (NVRA) to administer voter registration programs.

The Department remains committed to fulfilling its responsibilities under both the NVRA and Pennsylvania's voter registration law. Under my leadership, the Department will continue to promote voter registration and civic engagement through its outreach efforts across the Commonwealth, and we will continue to provide the tools counties need to maintain the accuracy and integrity of their voter rolls.

Executive Summary

In 2022, the Department of State (Department) worked closely with the public, each of the 67 county boards of elections, Commonwealth agencies designated with voter registration responsibilities, and voter registration advocacy organizations to help ensure all eligible Pennsylvanians who wanted to register to vote could do so. This report summarizes registration data and initiatives by these groups to support voter registration administration in Pennsylvania. The data contained in this report reflects transactions processed through the Statewide Uniform Registry of Electors (SURE) system between January 1, 2022, and December 31, 2022.

As of December 31, 2022, there were approximately 8.7 million registered voters in Pennsylvania. This represents a .31% decrease in the number of registered voters since the end of 2021 and a 1.76% increase since the end of 2018, the last general election cycle following a presidential election. Since 2018, the number of voters registered as members of the Democratic Party decreased, the number of voters registered as members of the Republican Party increased, and the number of voters who chose to be unaffiliated or registered with a non-major party increased. Voter roll numbers adjusted unevenly across the Commonwealth; the net changes ranged from a registrant increase of 2.76% in Chester County to a registrant decrease of 9.60% in Indiana County.

Pennsylvania voters registered in 2022 through a variety of methods, demonstrating the success of the Department's efforts to expand registration options. Over 30,000 registrations were submitted through agencies that partner with the Department to facilitate and update voter rolls when individuals use that agency's services. Approximately 351,000 voter registration applications were submitted online, and approximately 315,000 voters submitted paper applications.

During 2022, counties delivered more than 800,000 notices to registered voters relating to list maintenance. PennDOT delivered to counties an additional approximately 466,000 transactions indicating that a voter changed their address. Approximately 497,800 registrations were cancelled throughout the year. A total of 222 Pennsylvanians from 12 counties were inducted into the Pennsylvania Voter Hall of Fame, which honors voters who participate in at least 50 consecutive general elections.

On September 7, 2022, Governor Wolf signed Executive Order 2022-03 to expand voter access. The order designated eight commonwealth agencies and programs as Voter



Registration Distribution Agencies. These state offices are now tasked with providing customers with voter registration and education materials, displaying nonpartisan signs related to voter registration, and linking to voter registration resources on their websites. The Department looks forward to continued partnership with these agencies and programs to ensure Pennsylvanians are fully able to register to exercise their right to vote.

All data referenced in this report is available in this report's appendices. Data from previous years can be found in the respective annual reports, available online at dos.pa.gov.



Opportunities for Improvement

The Commonwealth has made great strides over the past several years to modernize voter registration and voter list maintenance activities, but there is more work to be done.

- The Department is currently working with PennDOT to improve the process flow of Motor Voter transactions and to increase from 14 to 31 the number of languages in which the Motor Voter screens are presented to customers.
- The Department believes that county election officials would benefit from the accuracy of voter rolls that fully reflect the data available through its Electronic Registration Information Center (ERIC) membership, including credible data regarding deceased registrants. However, that will require amendments to Pennsylvania's voter registration law, codified at 25 Pa.C.S. § 1505.
- The Department continues to prioritize the modernization of the SURE system to improve the convenience, speed, accuracy, and integrity of the voter registration and list maintenance processes.



Voter Registration Statistics

Through the SURE system, the county voter registration commissions maintain a complete list of all eligible registered voters in the Commonwealth. As of December 2022, there were 8,700,826 registered voters. The charts in this section represent a high-level snapshot of the change in voter registration over both the previous calendar year and the four-year period since the end of 2018. Details broken down by county and party can be found in Appendices A and B.

The chart below (Figure 1) depicts change in voter registration over the four-year period since the end of 2018 and whether that change represented growth or decline in party affiliation. The 2018 data was carried over from the [2018 annual report on voter registration](#); therefore, that data is as of December 31, 2018.




Figure 2: Total Voter Registration by Party, since 2018

The chart below (Figure 2) portrays changes in party affiliation over a four-year period between 2018 and 2022.

Areas of Growth and Decline

This section shows the voter registration growth and decline as compared to the previous year and over a four-year period. The charts are done in two parts: 1) growth and decline in registration for this year as compared to the previous year, and 2) growth and decline in registration over the four-year period between the end of 2018 and the end of 2022. For each section, the charts list counties within each category with their rate of growth or decline when compared to either last year's totals or totals from 2018. The tables show the growth or decline for all 67 counties.



Largest Overall Registration Growth and Largest Overall Decline Since 2021




Figure 3: Counties with largest overall registration growth and largest overall decline since last year

The chart below (Figure 3) shows the five counties with the largest overall registration growth and the five with the largest decline since last year.




Figure 4: Counties with largest overall registration growth and largest overall decline since 2018

List Maintenance

This section summarizes voter list maintenance activities conducted during the 2022 calendar year. Generally, “list maintenance” can be described as the process county election and voter registration officials use to manage voter registration rolls to ensure they are accurate. Both state and county election officials follow careful and appropriate steps, in compliance with federal and state laws, to determine whether a voter should be marked as *Inactive* or removed from the registration rolls.

List Maintenance Mailings

During 2022, counties sent more than 800,480 notices to voters: 337,730 Five-Year Notices; 232,138 National Change of Address (NCOA) Notices; 2,716 Duplicate Notices; 25,190 In-State Update Notices; 44,206 Out-of-State Update Notices; and 158,506 Address Verification Notices (AVNs).

When reviewing list maintenance activity summaries below, voter responses to most notices can be summarized into six broad categories:

- **Non-Response:** The voter never responded to the mailed notice.
- **Returned Undeliverable:** The notice could not be delivered via mail and was returned as undeliverable to the county voter registration commission.
- **Returned Confirmation:** The voter responded to the notice and confirmed their eligibility.
- **Voter Moved In County:** The voter responded to the notice and confirmed they moved to a new address within the county.
- **Voter Moved Out of County:** The voter responded to the notice and confirmed they no longer reside in the county but live elsewhere in Pennsylvania.
- **Voter Moved Out of State:** The voter responded to the notice and confirmed they moved outside of Pennsylvania.

Figures in this section are representative only of actions taken by December 31, 2022, as recorded by counties in the SURE system. If additional responses to notices were received after that date, they will not be represented below as the data is only point-in-time.



2022 Five-Year Notice Responses Summary




Figure 5: 2022 Five-Year Notice Summary

The Five-Year Notice (FYN) is a statutorily required, one-step mailing process. It is sent via forwardable mail. The purpose of this notice is to contact voters who have not had any activity on their record or have not voted within five years. Upon generation of this notice, the voter's record enters a list maintenance window, during which the voter record remains on the rolls but is updated to Inactive status. If the voter does not take any action or vote before the expiration of the list maintenance window, the voter's record is cancelled in SURE. The FYN provides an opportunity for the voter to respond so they may be reinstated to *Active* status. Upon a return to *Active*, the window to eventually cancel the voter record stops. Appendix D1 represents the activity recorded by counties on Five-Year Notice mailings.



2022 NCOA Notice Summary




Figure 6: 2022 NCOA Notice Summary

The NCOA Notice is a statutorily required two-step mailing process. Both notices are sent via forwardable mail. The first mailing, based on data received from the U.S. Postal Service (USPS) through its National Change of Address Program, is a notice which requires the voter to specify whether they have moved. Then, depending on their response, county officials update their records accordingly. These notices provide an opportunity for the voter to confirm their address or provide an update with their latest information to county officials.

Following the initial NCOA notice mailing, county officials send a second notice to voters who did not respond to the first mailing, or where the initial NCOA notice was returned as undeliverable. This second notice is commonly referred to as the Address Verification Notice (AVN). With the mailing of the AVN, the record is marked *Inactive*, triggering a waiting period before the voter record can be removed from the registration rolls. The period lasts until two federal general elections have passed. If the voter takes an action to update their record or vote within the waiting period, the voter record is returned to *Active* status, and the voter record is no longer eligible for removal. For example, if a voter was marked as *Inactive* in 2022 during list maintenance activities, and they do not make any changes on



their record or vote, the voter would be removed after the 2026 general election. Approximately 50,840 voters were marked *Inactive* following the 2022 NCOA list maintenance process. Appendix D2 represents the activity recorded by counties on NCOA mailings.

2022 ERIC Duplicate Notices

As part of the Department's membership in the ERIC program, it receives and shares data on potential voter duplication records with county officials. Because ERIC is a consortium of member states, and because there is no national voter registration database, ERIC is in a unique position to compare the data to find records of voters who may be potentially registered in more than one state. It also provides a report on voters who may be registered in more than one Pennsylvania county.

These pairs of voter records are identified for further review by county officials, to confirm whether the same person is potentially registered more than one jurisdiction. At the next stage in the process, notices are sent out the voter's address on record; during the 2022 calendar year, Pennsylvania counties mailed approximately 2,716 notices of potential duplication. The number of potential duplicate voter registrations has decreased by more than 80% since Pennsylvania started using this ERIC data in 2020, demonstrating the effectiveness of this program over time.




Figure 7: 2022 ERIC Duplicate Notice Summary

The chart below (Figure 7) represents a summary of the mailing responses. Appendix D3 represents the activity recorded by counties on ERIC Duplicate Notice mailings. After review, county officials update the voter's record, depending on that voter's response to the notice.

2022 ERIC In-State Moves




Figure 8: 2022 ERIC In-State Move Summary

In addition to comparing voter registration information, ERIC provides a report with data comparing voter registration information and Pennsylvania Department of Transportation (PennDOT) information to identify voters who may have moved without updating their registration. These data are also provided to counties.



The process for determining whether this new information accurately reflects a voter’s new status involves a one-step mailing procedure. Once the notice is queued and confirmed, the affected voter records are updated to *Inactive* status. Depending on the response – or nonresponse – to the mailer, the voter’s record may be updated to *Active*, remain in *Inactive* status, or be *Cancelled*. During 2022, approximately 25,190 notices were mailed to voters. Appendix D4 represents the activity recorded by counties on ERIC In-State Move mailings.

2022 ERIC Out-of-State Moves




Figure 9: 2022 ERIC Out-of-State Moves Summary

The data for potential out-of-state updates or moves are provided by ERIC. This process captures information where a voter within Pennsylvania appears to match another record from out of state that contains newer information. This may be an indication that the voter no longer resides in the state. Therefore, any identified registrants are sent a notice to confirm their move.

This process is a one-step mailing procedure. Once the notice is queued and confirmed, the affected voter records are updated to Inactive status. Depending on the response to the mailer or non-response, the voter’s record may be updated to Active, remain in Inactive status, or be Cancelled. During 2022, approximately 44,206 notices were mailed out to voters. Appendix D5 represents the activity recorded by counties in SURE system on ERIC Out-of-State Move mailings.



2022 Address Verification Notices (AVNs)




Figure 10: 2022 AVN Summary

A further list maintenance tool is the Address Verification Notice (AVN), which is used to determine if a voter is still eligible to vote at their documented address. In addition to the activities described above, with respect to voters who have potentially moved, counties send AVNs to *Inactive* voters when an initial contact attempt is returned as undeliverable. For example, if the United States Postal Services (USPS) returns a voter identification card to the county because it was undeliverable to the address used by the registrant, an AVN may be sent a voter. In 2022, approximately 158,506 AVNs were mailed to voters by county officials. The chart above (Figure 10) summarizes the responses received by county officials as of December 31, 2022. Appendix D6 represents the activity recorded by counties on AVN mailings.

PennDOT Change of Address Summary

In addition to registering to vote through more traditional means such as paper or online voter registration, the National Voter Registration Act of 1993 (NVRA) required states to incorporate voter registration opportunities into the driver's licensing application process at state motor vehicle authorities. As part of that process, voters have an opportunity to update their voter registration with their latest information to ensure the voter registration rolls are accurate, which is otherwise known as the change of address process.



During the 2022 calendar year, 466,898 change applications were processed by county officials to process and update voter records. Appendix D7 represents the activity recorded by counties in SURE system on PennDOT COA transactions.




Figure 11: 2022 PennDOT Change of Address Summary

Voter Registration Cancellations

During 2022, the SURE system recorded more than 497,800 voter registration cancellations. When a voter registration is cancelled, the record is tagged in the SURE system to identify the reason for cancellation. County voter registration offices may cancel the registration of both *Active* and *Inactive* voters. Note: Voters are marked as *Inactive* if, among other reasons, they do not respond to a county mailing asking them to confirm their residence or the mailing is returned by the USPS as undeliverable. For example, voters may be sent a mailing based on data the county receives in partnership with ERIC or when the voter fails to take some sort of action on their record within five years. See 25 Pa. C.S. §§ 1901(b)(1), 1901(b)(3), and 1901(c). *Inactive* voters who have failed to vote in two consecutive general (even-numbered year) elections must be cancelled pursuant to federal law. Table 3 represents the total number of cancellations by reason for the state. Figures in this section are representative of actions taken by December 31, 2022, as recorded by the counties in the SURE system. See Appendix D for details broken out by county.




Figure 12: Common Active Voter Registration Cancellations

Common Inactive Voter Registration Cancellations by Status and Year




Figure 13: Common Inactive Voter Registration Cancellations



National Voter Registration Act (NVRA)

NVRA Agency Registrations

The National Voter Registration Act (NVRA) requires that:

“(1) Each state shall designate agencies for the registration of voters in election for Federal offices.

“(2) Each state shall designate as voter registration agencies –

(A) all offices in the state that provide public assistance; and (B) all offices in the State that provide State-funded programs primarily engaged in providing service to persons with disabilities.” See 52 U.S.C. § 20506.

Pennsylvania, through its voter registration law, has incorporated these requirements for all elections. See 25 Pa.C.S. § 1325.

In consideration of these mandates, the Department continues to work with the covered agencies to ensure that the requirements of federal and state law are met. Since 2010, the Department has used computer-compatible registration forms with its partner agencies, which allows the Department to identify the source agency of registrations. The Department is thus able to track its efforts and ensure that agency efforts comply with the requirements of the NVRA and the Pennsylvania voter registration law.

On December 2, 2017, the Pennsylvania Department of Human Services (DHS) became the first Commonwealth agency to publicly deploy an online voter registration service with the Department. Through this online service, DHS clients submitted more than 26,700 applications in 2022. The Department also worked with the Department of Labor & Industry’s (L&I) Office of Vocational Rehabilitation and the Department of Health’s (DOH) Women, Infants and Children (WIC) program to deploy online services. Moving forward, the Department continues to look for other opportunities to modernize voter registration with state agencies. Table 4 (below) shows voter registration applications processed by counties from NVRA agencies. Appendix C2 shows the voter registration applications processed from each agency by county.

Total Agency Voter Registration Applications Processed from 2018 and 2022




Figure 14: NVRA Agency Voter Registrations Applications processed

PennDOT

Since 1995, PennDOT has played an integral role in voter registration through what is commonly known as the “Motor Voter” registration process. In 2003, the process became electronic. Motor Voter provides Commonwealth citizens with an opportunity to apply to register to vote while receiving or renewing their driver’s license or photo ID at a PennDOT center, as well as the opportunity to update their registration at a PennDOT center or online.

PennDOT voter registration applications are organized into two primary groups: 1) initial applications to register to vote (otherwise known as new applications); 2) Change of



Address applications to update the registrant's address on an existing record (otherwise known as change applications).

Application Process to Register to Vote at a PennDOT Center

PennDOT customers visit a photo license center with a driver's license application card provided by PennDOT. The application card contains a printed two-dimensional bar code. The bar code is scanned, and the computer system determines the customer's age. It then determines which customers will be at least 18 years old by the date of the next election and asks if the customer wishes to apply to register to vote.

The program is designed to ask customers if they are currently registered to vote. If not, they are provided the opportunity to apply to register.

- If a customer is not an eligible U.S. citizen, they do not see the Motor Voter application.
- Customers must confirm that they are U.S. citizens and qualified to register in the Commonwealth.
- Customers who choose to apply to register to vote are asked to confirm their county of residence and indicate a party preference. The customer is asked for optional information (telephone number and race).
- Customers are advised of the penalty for furnishing false information and are asked to sign a declaration that the information they have provided is true and correct to the best of their knowledge.
- Customers are provided a receipt indicating pertinent information about their voter registration application, including the date on which they applied at the photo license center. The receipt instructs customers to contact their county voter registration office if they do not receive a voter identification card within two weeks.

The completed applications are transmitted electronically by PennDOT's contracted vendor to the Department which, in turn, forwards the applications to individual county voter registration offices via the SURE system. For more detail on applications received from PennDOT license centers, see Appendix E.



Online Voter Registration

The Pennsylvania Online Voter Registration (OVR) Application was deployed August 27, 2015. The OVR application provides residents of Pennsylvania with the opportunity to register to vote or change an existing voter registration online and electronically submit voter registration data to their county voter registration office for processing. To ensure the successful roll out of online voter registration, the Department actively engaged election stakeholders including county election directors, the elections advocacy community, and Pennsylvania citizens. To ensure that the final product would be universally usable, the Department also engaged the Center for Civic Design to review the text and the logical flow of information. The Center also field tested the application in an urban and a rural community. This highly interactive development process resulted in a better product overall and one that has been embraced by Pennsylvania voters in overwhelming numbers, as evidenced by usage numbers.

During the 2022 calendar year, approximately 351,974 voter registration applications were submitted through the OVR application on the Department's website, including 152,796 applications for new voters. During the same period, a total of 315,524 paper applications were submitted to county voter registration offices. Since its inception, OVR has accounted for more than 3.2 million applications through the end of 2022.

Web Application Programming Interface (Web API)

A Web Application Programming Interface (Web API) was created for individuals and organizations that wish to develop a website to gather voter registration application data during voter registration drives. The Web API application contains information these organizations need to submit voter registration applications in an electronic format versus submitting paper applications. Entities that are granted access to use the Web API do not have direct access to the SURE system. This tool also interacts with PennDOT to capture signatures from valid driver's licenses and sends a Pending Missing Signature correspondence, if necessary. The Department manages a rigorous certification process to ensure individuals or organizations wishing to use the Web API tool meet Department-identified testing and security standards prior to approving their Web API account. As with online voter registration, signatures may be uploaded through the Web API interface, or a



request to receive a mail-in ballot may be submitted as a separate application in addition to the voter registration application.

Comparison of Voter Registration Method

The chart below depicts a general comparison of total applications submitted through OVR, OVR Web API (which is a subset of online voter registration), and paper applications. In addition to method of registration, these statistics are also broken down by month to highlight volume throughout the election cycle. This data will not reconcile with the total OVR registrations processed in the voter registration system because it does not represent the final disposition of the applications submitted via OVR. For example, a registrant may submit duplicate applications that are declined after processing.




Figure 15: OVR vs. Web API vs. paper applications until December 23, 2022




Figure 16: Demographics of OVR use

Voter Hall of Fame

The Pennsylvania Voter Hall of Fame program is administered by the Department of State's Bureau of Commissions, Elections, and Legislation. The program was established to promote awareness and to encourage all Pennsylvanians to exercise their right to vote. The Voter Hall of Fame publicly honors Pennsylvanians who have voted in at least 50 consecutive November elections. The inductees serve as ambassadors in their communities – leading by example and encouraging participation in the electoral process. In 2022, the Department inducted 222 citizens from 12 counties into the Voter Hall of Fame. The 222 new members bring total membership to 24,226, with members representing all 67 counties across the Commonwealth.



Conclusion

The administration of voter registration in the Commonwealth relies on a collaborative approach between the Department of State and Pennsylvania's 67 counties. By providing resources and sharing expertise, the Department works with county election officials to promote the secure, efficient, and inclusive composition of voter rolls. Well-maintained voter rolls lead to well-conducted elections.

This report reflects the hard work of the Department and its county partners to expand voter registration opportunities and to ensure the accuracy of Pennsylvania's voter rolls. At the same time, this report details the ways in which it hopes to improve on these advances, by working with its state and local partners to maintain a voter registration system that accurately and completely reflects the eligible voters of this Commonwealth.
