# In Solidarity with Nurses

We are in solidarity with nurses across the Montefiore Health System in Mount Vernon, New Rochelle and Nyack Hospitals who are fighting for safe staffing with strong accountability for patient safety, respectful, competitive wages that help recruit and retain nurses, community investment, and a fair contract for nurses and patients.

At a time when non-profit hospital CEO pay is rapidly increasing, with seven-figure salaries and Wall Streettype bonuses, there is no excuse to reduce services at these hospitals or cut corners with nurse staffing, which puts patient safety at risk.

Montefiore must invest in these hospitals and ensure that our communities have the highest quality healthcare possible. We call on Montefiore to hear NYSNA's demand that our nurses and patients deserve better.

Nurses are raising important public health issues around safe staffing, equity and access that must be addressed. We urge the hospital administration to agree to nurses' demands that focus on safe staffing, fair pay and community health. This would show a real investment in our communities and create the kind of quality jobs we need.

We have strong concerns that Montefiore administration is not adhering to safe staffing ratios. NYSNA nurses have been speaking out against unsafe staffing at Montefiore for years, and yet hospital management is not responding with the urgency required to recruit and retain nurses.

Montefiore must commit to fair pay and improvements to health and educational benefits that honor nurses' service and quality care.

By agreeing to strong contracts, we can work to address the health and safety needs of our communities.

We urge you to agree with the nurses' just demands, negotiate and commit to fair contracts, and invest in the Lower Hudson Valley communities served by Mount Vernon, New Rochelle and Nyack Hospitals.
